

Landing Fees

All fees are charged per 1,000 kg or portion thereof, and are based on the Maximum Take Off Weight of each jet, turboprop or rotary wing aircraft landing at YQR. There is no difference between domestic or international flights.

* Minimum landing fee is \$18.94

Airport Infrastructure Levy (AIL)

Applicable to all jet and turboprop aircrafts whose operation is currently exempt from Passenger Facility Fees. This fee will be assessed at \$1.50 / 1,000 kg per landed aircraft.

Glycol Recovery

The Regina Airport Authority (RAA) will recover costs from the airlines for glycol disposal, subject to a 25% administration fee. The recovery will be billed monthly on a seasonal basis.

Apron 3 & 4 - Commercial Hangar Line

Aircraft parking fees are assessed based on aircraft weight and on length of stay. This apron with tie down capabilities will generate a daily fee for all aircraft parking in excess for six (6) hours through a revived parking fee structure. Monthly and Annual Maximums will be made available for aircrafts up to 5,000 kg (only). **Note:** Monthly and annual aircraft parking fees are dependent upon availability and location.

International Waste Recovery

RAA will cost recover from airlines on a monthly basis for international waste disposal based on the published flight schedule at \$0.21 per landed seat on each international flight. Upon conclusion of the operating season RAA will issue an adjustment billing reflecting any variances resulting from actual activities.

Aircraft Parking Fees (Apron 1 & 2 Locations)

Itinerant parking fees are charged on all aircrafts parked for periods of 90 minutes or more. Parking for more than six (6) hours but less than 24 hours is counted as one day.

Passenger Facility Fee (PFF)

A fee for departing passengers, less the handling fee provided for in the PFF Memorandum of Agreement or PFF Agreement is as follows:

For Non-Signatory Air Carriers

A fee will be charged for departing passengers from any location at Regina International Airport including Fixed Base Operators on aircraft where revenue is derived from the sale of a seat, whether it be publicly or privately available.

These operators are to submit passenger numbers on a monthly basis to determine proper assessment of charges. In the event that passenger numbers are not provided by the 7th day of the following month, the aircraft operator will be assessed based on the total number of seats.

The Fee does not apply to aircraft with less than twenty (20) passenger seats or rotary wing aircraft.
